

ASSISTANCE WITH FEDERAL AGENCIES
If you have a concern regarding the IRS, passports or foreign travel, veterans issues, Medicare or Medicaid, military cases, HUD, the Department of Agriculture, etc., please contact one of my constituent services representatives in my Tulsa district office.

U.S. SERVICE ACADEMY APPOINTMENTS
An individual interested in attending one of our nation's Service Academies must meet the admissions requirements of the academy and receive a Congressional nomination in order to gain admission. Any interested applicants should contact my Tulsa district office.

CONGRESSIONAL INTERNSHIPS
Internships are available in my district offices or in my Washington, D.C., office. To be considered for an internship position, please contact one of my offices. Please visit my website for more information or to download an application.

U.S. CAPITOL FLAGS & TOURIST ATTRACTIONS
To purchase an American flag that has flown over the U.S. Capitol, call the Washington, D.C., office. My office is pleased to provide a comprehensive list of museums, attractions and tours in the D.C. area. Most of the attractions in the area are free and open to the public. If you have questions regarding Washington, D.C., sites, please do not hesitate to call.

U.S. CAPITOL TOURS & GALLERY PASSES
If you would like to see the House or Senate in session, gallery passes are available from the Washington, D.C., office. Please make your request 4-6 weeks in advance, if possible.

WHITE HOUSE GREETING LETTERS/CARDS
My office can facilitate constituent receipt of letters from President George W. Bush honoring birthdays (for ages 80 or older) or wedding anniversaries (50 or more years). Eagle/Girl Scout recognition letters are also available. The White House usually requires 4-6 weeks to process a letter request. Contact my Washington, D.C., office for help in this matter.

SECURING AMERICA'S BORDERS

I am working hard to bring positive reform to our immigration system and develop a responsible immigration policy that stops illegal immigration. Illegal immigration presents a threat to the security of our borders and the rule of law in our nation. Simply put, border security is national security. I strongly support legislation that secures our borders and reestablishes respect for the rule of law in our country by:

- **Establishing English as the official language of our Government**
- **Establishing more physical barriers along the border, including over 700 miles of double layer border fencing.**
- **Putting an end to sanctuary city policies that actually encourage illegal immigration.**
- **Providing employers the tools they need to ensure they are hiring a legal workforce.**
- **Providing state and local law enforcement the authority they need to protect Oklahomans from criminal illegal aliens.**

No To Amnesty

I will continue to oppose granting amnesty, in any form, to illegal aliens. We are a nation of laws and we must not reward those who have already broken the laws of our Nation.

Bringing Immigration Enforcement to Tulsa

I was proud to help the Tulsa County Sheriff's Office (TCSO) complete their training in the 287(g) federal immigration training program. Now TCSO has 27 sheriff's deputies on the ground with the authority and training to help enforce federal immigration laws and put criminal illegal aliens on notice that their days of harming our communities and evading the law are over.



CONTROLLING SPENDING

2008 promises to be an important year for you and your family, as the Democrat led Congress seeks to implement its inflated fiscal agenda.

Spending

In the first session of the 110th Congress, the House of Representatives, under the direction of a Democrat Majority, passed spending legislation that was roughly \$24.3 billion over the President's request for domestic spending—\$24.3 billion that American families are going to have to make up for out of their pocketbooks. In an effort to reign in out of control spending, I voted against these spending measures.

Anti-Pork Votes against Earmarks
